Since there is a possibility of igniting behind when removal of a leakage thing is imperfect, it is careful enough.

<b>7.1 Precautions for safe handling</b>	Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapour or mist.
