In case of fire in the surroundings: Keep containers cool by spraying with water. Eliminate all ignition sources if safe to do so. When extinguishing fire, be sure to wear personal protective equipment

Absorb spilled material in dry sand or inert absorbent before recovering it into an airtight container. In case of large amount of spillage, contain a spill by bunding. Fire-extinguishing devices should be prepared in case of a fire. Use spark-proof tools and explosion-proof equipment.

Use a ventilation, local exhaust if vapour or aerosol will be generated. Avoid all contact!
