Fire-extinguishing devices should be prepared in case of a fire. Use spark-proof tools and explosion-proof equipment.

7.1 Precautions for safe handling

Handling is performed in a well ventilated place. Wear suitable protective equipment. Prevent generation of vapour or mist. Keep away from flames and hot surfaces. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Wash hands and face thoroughly after handling. Use a closed system if possible. Use a ventilation, local exhaust if vapour or aerosol will be generated. Avoid contact with skin, eyes and clothing. A small amount of copper chip is added as a stabilizer. Separation such as filtration should be taken as necessary.

Keep container tightly closed. Store in a refrigerator. Store under inert gas. Store locked up. Store away from incompatible materials such as oxidizing agents. Heat-sensitive, Light-sensitive, Air-sensitive
