Explosion risk in case of fire. Fight fire remotely due to the risk of explosion. Take care as it may decompose upon combustion or in high temperatures to generate poisonous fume. Carbon dioxide, Carbon monoxide, Hydrogen fluoride, Boron oxides, Silicon oxides, Hydrogen Iodide

5.3 Advice for firefighters

Fire-extinguishing work is done from the windward and the suitable fire-extinguishing method according to the surrounding situation is used. Uninvolved persons should evacuate to a safe place. In case of fire in the surroundings: Keep containers cool by spraying with water. Eliminate all ignition sources if safe to do so. When extinguishing fire, be sure to wear personal protective equipment

7.1 Precautions for safe handling

Handling is performed in a well ventilated place. Wear suitable protective equipment. Be careful not to cause leakage, overflow, or dispersion. Steam should not be generated unnecessarily. Keep away from heat/sparks/open flame/hot surfaces. -No smoking. Take measures to prevent the build up of electrostatic charge. Use explosion-proof equipment. Avoid shock and friction. Wash hands and face before breaks and immediately after handling the product. Use a closed system if possible. Use a local exhaust if dust or aerosol will be generated. Avoid contact with skin, eyes and clothing.

Keep container tightly closed. Store in an explosion-proof freezer. Store under inert gas. Protect from moisture. Store locked up. Be sure not to give the container unexpected impacts, such as falling down or falling off. Store away from incompatible materials such as oxidizing agents. Heat-sensitive, Moisture-sensitive, Air-sensitive
